A CDSC Success Story

Without naming names, this mediation involved a tenant unaware of RAFT. (Residential Assistance for Families in Transition) Like many tenants, this tenant had lost a year of employment and had been a good paying tenant before that long stretch of unemployment. The landlord waited a long time before filing the lawsuit because the landlord had a long and positive relationship with the tenant.

The mediation process allowed the tenant to learn about RAFT, they applied for

RAFT, the landlord was paid, the tenant was reemployed, and the relationship is now back to where it was before the pandemic. The parties were very angry in the beginning, the tenant because the tenant thought the landlord did not care, and the landlord because they were not getting paid and were in severe financial difficulty.

Through the mediation process, the parties realized that it was not the fault of either of the parties, but simply a terrible situation both parties were in. When they realized the situation, they both worked together, resolved their situation by getting the landlord paid through RAFT, and the case was dismissed.

The mediation process helped them focus on the problem as a joint problem to solve together.

Helping families in a difficult time: Parent Mediation Program

For many couples with children, divorce or separation can present significant

challenges with parenting decisions. From childcare, to medical decisions, to figuring out choices around education and more, former partners may find it difficult to navigate coming to an agreement without help.

Thanks to the Massachusetts Office of Public Collaboration at UMass, CDSC is one of five programs across the state which participates in the Parent Mediation Program – or PMP. Through PMP, parents can access up to 4 (and in some cases, 8) free hours of mediation services, and take advantage of all the benefits of mediation: maintaining control over the decision making process; a less expensive and less time-consuming process than litigation; and participating in a process that often reduces hostility and instead, promotes relationships. Some of our PMP participants have used this program as a prelude to divorce mediation, while others use our services solely for their parenting decisions.

Volunteer Spotlight: John Berke

It was time to renew his long-term office lease, and John Berke had second thoughts.

A long-time solo practitioner with a focus on family law and litigation, John took his hesitation as a chance to take a break from his work, travel and think about how the coming years might evolve. A three-month stay in Ghana that included working part time as a volunteer mediator confirmed his interest in mediation. When he returned to Massachusetts, his next steps included training and volunteering with CDSC. "I think my years as an attorney help me keep the whole situation in mind,



without being pulled into side issues," says John who attended Brandeis University and Fordham Law School. "It helps me focus on the essential issue."

Like many mediators, John finds satisfaction in helping people come to an agreement, especially when at the outset it looks impossible. "It helps people to put a problem behind them."

Established in 1979, the Community Dispute Settlement Center (CDSC), is a private, not-for-profit mediation and training center dedicated to providing an alternative and affordable forum for resolving conflict.

CDSC promotes better ways to understand and deal with conflict through skilled teams of probono mediators, training programs in mediation and conflict management, and broad community outreach.
